ORDINANCE AUTHORIZING AN AGREEMENT WITH THE METROPOLITAN SEWER SUBDISTRICT D/B/A METROCONNECTS PERTAINING TO ANNEXED PROPERTY AND APPROPRIATING FUNDS FOR THE PAYMENT OF CERTAIN FEES PURSUANT TO THE AGREEMENT

SUMMARY BACKGROUND:

This Ordinance approves an Intergovernmental Agreement with Metropolitan Sewer Subdistrict which is a special purpose district providing sewer service within its defined territory. The City has annexed property within that territory and the parties have reached agreement concerning the District's loss of revenue as a result of the City's annexation efforts.

IMPACT IF DENIED:

The Agreement will not be approved.

FINANCIAL IMPACT:

\$252,706 lump sum payment to Metro which covers the time period an agreement was not in place which addressed the new Metro billing structure.

AUTHORIZING AN AGREEMENT WITH THE METROPOLITAN SEWER SUBDISTRICT D/B/A METROCONNECTS PERTAINING TO ANNEXED PROPERTY AND APPROPRIATING FUNDS FOR THE PAYMENT OF CERTAIN FEES PURSUANT TO THE AGREEMENT

WHEREAS, the Metropolitan Sewer Subdistrict d/b/a Metroconnects (“Metro”) is a Special Purpose District organized and existing under South Carolina law that provides sewer services within its defined service territory; and

WHEREAS, the city of Greenville (the “City”) has annexed certain property within said territory; and

WHEREAS, the City and Metro previously entered into an agreement, dated September 20, 1991, to address Metro’s loss of revenue as required by State law; and

WHEREAS, in 2019 Metro switched from a property tax revenue model to a billing system based on water usage and that change created a need for a new agreement between the parties; and

WHEREAS, the City and Metro have reached agreement concerning how to equitably balance Metro’s loss of revenue associated with those annexed properties as more fully set forth in the Intergovernmental Billing and Collection Agreement attached hereto and made a part hereof as Attachment A (the “Agreement”); and

WHEREAS, the City and Metro intend to replace and supersede the agreement of September 20, 1991, with the aforementioned Agreement; and

WHEREAS, City Council desires to approve the Agreement and appropriate the monies necessary to make the retroactive payment called for thereunder;

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF GREENVILLE, SOUTH CAROLINA that an agreement between the City and Metropolitan Sewer Subdistrict d/b/a Metroconnects is approved in substantially the same form as the Agreement which is attached hereto and incorporated herein by reference as Attachment A. The City Manager, in consultation with the City Attorney, may make or accept minor modifications to the wording and designations of the attached documents as may be necessary or appropriate, provided there is no compromise of the substantive purposes of this Council action. Should the City Manager or City Attorney, or both, determine that any modification of previously negotiated terms is significant and warrants further action by City Council, then the matter shall be presented to Council for further review before the final execution. There is appropriated the sum of \$252,706, as reflected on Attachment B, for the payment of millage and sanitation fees pursuant to the Agreement. This Ordinance shall become effective upon passage of the second and final reading.

INTERGOVERNMENTAL BILLING AND COLLECTION AGREEMENT

This agreement is entered into this ____ day of _____, 2020 (the “**Effective Date**”), by and between the City of Greenville (the “**City**”), a municipality of the State of South Carolina (the “**State**”) and the Metropolitan Sewer Subdistrict dba MetroConnects (“**Metro**”), a special purpose district created by Act No. 687 of the Acts and Joint Resolutions of the General Assembly of the State for the year 1969, as amended by Act No. 1842 of the Acts and Joint Resolutions of the General Assembly of the State for the year 1972 (together, the “**Enabling Acts**”) authorized to provide sanitary sewer collection service (“Metro Service or Metro Services”), each a “Party” and together the “Parties.”

RECITALS:

A. The City has periodically annexed certain properties to which Metro provides Metro Services (as defined below) or to which Metro is authorized to provide Metro Services under the provisions of the Enabling Acts. In most instances, where the City annexes property to which Metro is authorized to provide Metro Service, Metro continues to provide the Metro Service to existing customers as well as to new development within these annexed areas.

B. Prior to July 1, 2019, Metro Services were funded through a sewer service fee and ad valorem property taxes charged to its customers located within its boundaries. When property in Metro’s service territory was annexed by the City, the City remitted the amount of ad valorem property taxes that Metro would have otherwise collected through Greenville County but for the annexation directly to Metro on an annual basis pursuant to an agreement between the parties referenced below.

C. Beginning on July 1, 2019, Metro adopted a new funding structure comprised of monthly fixed service charges and volumetric flow charges based on water consumption collected directly from connected customers of Greenville Water (the “User Charge Rate Structure”).

D. The City and Metro have previously entered into an agreement, dated September 20, 1991, under which Metro provided Metro Service to Customers within the City Limits. The Parties intend to replace and supersede the agreement of September 20, 1991, with this Agreement, which provides that Metro will continue to provide the Metro Services on behalf of the City and will collect Metro User Charges for the Metro Services directly from the City pursuant to the terms of this Agreement, for those current customers listed in Schedule A based on their water usage as provided by Greenville Water. Future City of Greenville annexations of Metro Customers (customers connected to Metro’s sanitary sewer system “Metro Customers”) will be billed Metro’s User Charge Rate by Greenville Water on behalf of Metro and the City shall have no obligation to Metro, financially or otherwise, with respect to such Metro Customers after annexation into the City.

E. This agreement is only intended to apply with respect to those customer accounts associated with properties that are, or would be but for the act of annexation by the City, within Metro’s boundaries as of December 31, 2020. The parties acknowledge that Metro’s boundaries may be enlarged as a result of contemplated legislative action by Greenville County Council or through agreement with one or more of Berea Public Service District; Gantt Fire, Sewer and Police District; Marietta Water, Fire, Sanitation, and Sewer District; Parker Sewer and Fire Sub-District; Taylors Fire and Sewer District; and Wade Hampton Fire and Sewer District (each a “County Sewer Collection SPD”). In the event that the Metro service area is enlarged to include the boundaries of a County Sewer Collection SPD, Metro and the City shall enter into a separate agreement for any customer accounts that may be located within the City Limits and the enlarged Metro boundaries.

NOW, THEREFORE, and in consideration of the premises set forth in the recitals above, and the mutual covenants and obligations contained herein, the receipt and sufficiency of which are hereby acknowledged, the City and Metro agree as follows:

Article 1.
Definitions

Section 1.01. Defined Terms. In addition to any words and terms elsewhere defined in this Agreement, the following words and terms as used in this Agreement shall have the following meanings unless some other meaning is plainly intended:

“**Agreement**” means this Agreement.

“**City Limits**” means the corporate boundaries of the City, as they may be expanded through annexation or otherwise over time.

“**City User Charge**” means the monthly fees and charges the City imposes upon residents and businesses within the corporate limits of the City for sanitary sewer service which such charges are subject to adjustment from time to time in the City’s sole discretion.

“**Connected City Customer**” means any Metro Customer located within the City Limits that is connected to the Metro System to which Metro provides Metro Service on behalf of the City. The current list of Connected City Customers is identified on **Schedule A** attached to this Agreement. The term “Connected City Customer” shall apply to any building or other improvement connected to a sanitary sewer collection line owned and/or operated by Metro.

“**Metro Customer**” means any Greenville County tax parcel that receives Metro Service from Metro or is located within the current, future or former boundaries of Metro.

“**Metro’s Policies**” means those policies, procedures, practices, standards, capacity requirements, permitting procedures, regulations, and other requirements for connection to the Metro System or the provision of Metro Service, as adopted by Metro and as they may be supplemented or amended from time to time.

“**Metro Service**” means the collection of sewage and the transmission by and through the Metro System to the trunk lines of or sewage treatment disposal facilities of Renewable Water Resources, or any successor entity.

“**Metro System**” means the system of Sanitary Sewer Collection Lines and appurtenances connected thereto that are owned and operated by Metro, which shall include those Sanitary Sewer Collection Lines and appurtenances existing as of the Effective Date of this Agreement and those installed, constructed, modified, improved, or replaced thereafter within the boundaries of Metro as of December 31, 2020.

“**Metro User Charge**” means, as for each Metro Customer, a monthly fixed service charge and volumetric flow charge based on water consumption in the amount equal to the charge that would be applicable to such Metro Customer based upon the schedule of Metro User Charges established by Metro from time to time. The Metro User Charge from July 1, 2019 through June 30, 2020 consisted of (a) a fixed monthly charge of \$11.00 plus (b) \$1.54 per each 1,000 gallons of water used. Commencing on July 1, 2020 the Metro User Charge was amended to (a) a fixed monthly charge of \$11.25 plus (b) \$1.57 per each 1,000 gallon of water used. The Metro User Charge shall be subject to adjustment from time to time by Metro.

“**SCDHEC**” means the South Carolina Department of Health and Environmental Control, or such successor agency of the State.

“**Sanitary Sewer Collection Line**” means any lateral or collection line used for the purposes of collecting and transmitting sanitary sewage.

“**Unconnected Customer**” means, as of the Effective Date of this Agreement, any customer or property that is not connected to the Metro System, does not receive Metro Service and is located within the boundaries of Metro as established by the Enabling Acts.

“*Water Usage Report*” means that certain report provided by Greenville Water (or any successor water utility provider) to the City and Metro that lists the water volume/usage amounts for each Connected City Customer for the current billing cycle as it is billed by Greenville Water.

Article 2.

Term

Section 2.01. Term. The term of this Agreement shall commence as of the first day of the first month beginning after the Effective Date, unless the Effective Date is the first day of a month, in which case the term shall commence on the Effective Date. The term of this Agreement shall continue for a term of five (5) years, and shall automatically renew at the end of the initial term for two successive terms of five (5) years each; provided, however, that this Agreement shall not automatically renew for a successive term if, at least ninety (90) days prior to the end of the initial term or any successive term, either Party provides written notice to the other Party of its intention that this Agreement not automatically renew. In the event the City chooses not to renew this Agreement, then the City agrees to release those properties listed in Schedule A to be billed by Greenville Water at Metro’s existing rate on behalf of Metro and the City shall have no further obligation to Metro whatsoever with respect to such Connected City Customers.

Article 3.

Service Rights and Connection Permits

Section 3.01. Service Rights.

(a) For the purpose of this Agreement, Metro Service may be “*Made Available*” by Metro if an Unconnected Customer (i) is located in a geographic area or drainage basin that is conducive to be connected to the Metro System pursuant to the then applicable Metro Policies; (ii) has petitioned Metro or the City to be connected to the Metro System; and (iii) the service needs of such Unconnected Customer may be accommodated by Metro pursuant to Metro’s Policies in effect at the time of connection. If Metro Service may be Made Available by Metro pursuant to this Section, Metro shall permit connection to the Metro System and provide Metro Service pursuant to the terms of this Agreement and will be billed by Greenville Water on behalf of Metro at Metro’s current rates.

(b) If Metro determines, pursuant to Section 3.01(a) above, that Metro Service is not available and may not be Made Available to an Unconnected Customer annexed by the City or otherwise located within the City Limits, Metro shall not be obligated to upgrade any portion of the Metro System to accommodate any such Unconnected Customer; however, Metro may, in its sole discretion, make any such necessary upgrades, improvements, or extensions at its sole expense. In the event that Metro determines that Metro Service may not be Made Available to support any new or expanded development within the City Limits, the City may, in each instance in the City’s sole discretion and at the City’s sole expense, make whatever modifications or extensions to the City’s sewer system to provide sewer services to such Unconnected Customer which cannot be served by Metro’s System.

Section 3.02. Notification of Annexation. At such time as the City approves the annexation for any parcel located the within the boundaries of Metro at the time of annexation, the City shall provide Metro with written notification thereof, including a copy of the annexation ordinance.

Section 3.03. Connection Permits.

(a) *Development requiring installation of Sanitary Sewer Collection Lines.* Where any new or expanded development requires the installation or construction of Sanitary Sewer Collection Lines or appurtenances by a developer or other third-party that are intended to be accepted into the Metro System, the third-party shall submit a permit application for such

connection directly to Metro, and Metro shall coordinate directly with the third-party to ensure compliance with Metro's Policies. To the extent that any third-party contacts the City regarding new or expanded development where it is anticipated that new Sanitary Sewer Collection Lines or other appurtenances will have to be accepted into the Metro System, the City shall promptly refer the third-party to Metro. Metro shall notify the City of its approval of any permit application from a third-party within five (5) business days of Metro's approval thereof. Metro Service connections thereafter made to the Sanitary Sewer Collection Lines accepted into the Metro System shall be made in a manner consistent with Metro's Policies in effect at the time of connection.

(b) *Customers to be connected to existing Sanitary Sewer Collection Lines of the Metro System.* Permit applications for service connections to the Metro System must be obtained directly from Metro and shall be made in a manner consistent with Metro's Policies in effect at the time of connection.

Article 4.

Payment for Metro Services; the City Charges for Metro Services

Section 4.01. Adoption of Metro User Charges. The calculation of the Metro User Charges shall be based upon the schedule of Metro User Charges adopted from time to time by Metro. Metro may, in its sole discretion, adjust the schedule and amount of Metro User Charges at any time; provided, however, the amounts of the Metro User Charges applicable to the Connected City Customers and used to calculate the fees due hereunder shall be the same as the Metro User Charges charged, imposed, or levied uniformly upon all Metro Customers located within Metro's boundaries.

Section 4.02. Billing and Collection of Metro User Charges for Connected City Customers. The parties acknowledge that the Board of Commissioners of Public Works d/b/a Greenville Water ("Greenville Water") is the sole billing and collection agent for the City User Charge and the Metro User Charge within the City of Greenville. The monthly amount to be paid by the City to Metro hereunder shall not be reduced due to the failure of Greenville Water to collect and remit to the City any City User Charge from the Connected City Customers listed on Schedule A when due or any reduction in the City User Charge by the City.

Section 4.03. Calculation and Payment of Metro User Charges for Connected City Customers listed on Schedule A. This Section 4.03 shall only apply to Connected City Customers listed on Schedule A. On or before the twentieth (20th) day of each month, the City shall use commercially reasonable efforts to cause Greenville Water (or any successor water utility provider to Greenville Water) to provide the Water Usage Report to both Metro and the City for the determination of the Metro User Charge to be paid from the City to Metro. On or before the thirtieth (30th) day of each month, the City shall remit to Metro the amount of the Metro User Charge that Metro would have collected from the Connected City Customers if Greenville Water had collected such charges directly on behalf of Metro. Recognizing that Metro is owed Metro User Charges from Connected City Customers beginning with the July 2019 Greenville Water monthly billing cycle, the City shall use commercially reasonable efforts to cause Greenville Water, within twenty (20) days of the Effective Date of this Agreement, to provide the Water Usage Report to both Metro and the City for Connected City Customers from the July 2019 billing cycle through the Effective Date (the "Consolidated Report"). Within twenty (20) days of receipt of Consolidated Report, the City shall remit to Metro the amount of the Metro User Charge that Metro would have collected from the Connected City Customers if Greenville Water had collected such charges directly on behalf of Metro from the July 2019 billing cycle through the Effective Date (the "Initial City Payment"). The foregoing notwithstanding, the City shall retain all City User Charges collected from the Connected City Customers.

Section 4.04. Billing and Collection of Metro User Charges for Future Connected City Customers. The parties hereby acknowledge and agree that all Future Connected City Customers shall be charged the applicable Metro User Charges through Greenville Water, the City shall not otherwise charge the City User Charge to any Future Connected City Customer, and the City shall have no obligation whatsoever to Metro with respect to any Future Connected City Customer. For purposes of this Agreement, the term “Future Connected City Customer” means any customer annexed into the City after the Effective Date which (a) is located within Metro’s boundaries as of December 1, 2020 and (b) receives, or continues to receive, Metro Service following the date of annexation.

Section 4.05. Billing and Collection of Metro User Charges for Unconnected Customers. The parties hereby acknowledge and agree that for all Unconnected Customers where Metro Service is Made Available pursuant to Section 3.01 of this Agreement, upon connection to the Metro System, Metro shall charge and collect all Metro User Charges through Greenville Water, the City shall not otherwise charge the City User Charge to such Unconnected Customers, and the City shall have no obligation whatsoever to Metro with respect to any such Unconnected Customer.

Article 5.

Default; Remedies; Dispute Resolution

Section 5.01. Default. In the event either Party determines the other Party has failed to comply with the terms and conditions of this Agreement, such Party shall provide written notice on non-compliance to the other Party providing with reasonable specificity the facts which show non-compliance. The Party on notice shall have thirty (30) days within which to (i) identify, in writing, the course of action it shall take to come into compliance and the time period within which such course of action shall be executed, or (ii) refute with reasonable specificity the noticing Party’s statement on non-compliance. The noticing Party shall then have thirty (30) days within which to accept the response or to engage the Party on notice in negotiation. By mutual written consent the parties may extend the time period for negotiation or consideration of such matter. The resolution of any such matter in dispute shall be memorialized in writing by the Parties.

Section 5.02. Mediation as a Prerequisite of Filing a Civil Action. In the event that the Parties are not able, pursuant to Section 5.01 hereof, to arrive at a mutually agreeable resolution to any matter in dispute within time provided for therein, or any mutually agreed upon extension thereof, either Party may invoke this provision of mandatory mediation by delivering written notice to that effect to the other Party by certified mail or hand delivery supported by affidavit of the delivering person. The Parties shall mutually agree upon a mediator or, in the event the Parties are unable to mutually agree upon a mediator, request the Administrative Judge for the Court of Common Pleas of Greenville County to make such a selection. The mediator shall convene a mediation session within fifteen days of the selection, or as soon thereafter as the mediator determines to be feasible and without undue delay. Any agreed upon resolution or method of compliance shall be reduced to writing and signed by the authorized officer of each Party. All costs and fees associated with mediation, including the mediator’s fee, shall be borne equally between the City and Metro. In the event that the Parties are unable to reach a mutually agreeable resolution through mediation, either Party may seek any remedy available to such Party, in law or equity, by filing an action in the Court of Common Pleas of Greenville County.

Section 5.03. No Offset. The City’s obligation to make payments under this Agreement shall be absolute and unconditional and shall not be subject to reduction, right of offset, counterclaim, or deduction.

Article 6.

Miscellaneous Provisions

Section 6.01. Regulations Applicable to Connected City Customers. All Connected City Customers shall be subject to Metro's Policies. The City shall take any and all reasonable actions necessary to assist Metro in the enforcement of such policies, procedures, and regulations. To the extent that Metro's assistance is required to enforce or implement any Metro Standard, Metro shall take any and all reasonable actions necessary to assist the City in the enforcement thereof.

Section 6.02. Service Calls. In the event that the City receives any service call related to a Connected City Customer or any portion of the Metro System, the City shall immediately refer the caller to Metro and notify Metro of the service call. Metro shall respond to such call in the normal course of business.

Section 6.03. Good Operating Condition of Sanitary Sewer Collection Lines. Metro agrees, at its sole expense, to maintain the portions of the Metro System located within the City Limits in good operating condition in accordance with engineering standards generally used within the sewer utility industry and in compliance with all appropriate regulatory agencies, including but not limited to, SCDHEC and the United States Environmental Protection Agency.

Section 6.04. Attorney's Fees. Each party will bear its own costs and expenses, including attorneys' fees, arising out of or relating to this matter.

Section 6.05. Authorization. Each of the Parties hereto hereby represents and warrants that all appropriate action has been taken by their respective governing bodies to authorize the execution of and the performance of the obligations set forth in this Agreement and that the persons executing this Agreement on behalf of each Party has been duly authorized to do so.

Section 6.06. Entire Agreement and Modification. This Agreement constitutes the entire agreement between the Parties. All prior representations and discussions have been merged into this document and no provision shall survive the execution of the Agreement unless it is contained herein. This Agreement may not be amended except in a writing with a document signed by both parties and with a formality of execution the same as this Agreement.

Section 6.07. Third-Party Beneficiaries. There are no third-party beneficiaries to this Agreement. No third-party may assert any claim under this Agreement and this Agreement does not, and is not intended to confer in favor of any other persons or entities any rights or remedies whatsoever.

Section 6.08. Severability. In the event any provision of this Agreement, or the actions taken to adopt this Agreement, are held invalid or unenforceable by any court of competent jurisdiction, such holding shall not invalidate or render unenforceable any other provision hereof.

Section 6.09. Counterparts. This Agreement may be signed in counterparts by any one or more of the parties or signatories hereto, and each such counterpart shall be deemed an original and part of a single instrument for all purposes.

Section 6.10. Release of City by Metro for Prior Annexation of Property. Upon payment of the Initial City Payment, Metro hereby holds harmless and forever releases, discharges the City, as well as its officials, employees and agents, from and against any all claims of any nature whatsoever arising out of, or related in any manner to, the repayment of the Metro User Charge or any ad valorem tax payments otherwise due to Metro after the City's annexation of the current Connected City Customers. This release is not intended to relieve the City of its obligation to make any future payments contemplated under this Agreement.
