ORDINANCE/RESOLUTION CAPTION:

AN ORDINANCE TO APPROPRIATE \$30,200 IN THE MISCELLANEOUS GRANT FUND FOR THE FY 2020 ASSISTANCE TO FIREFIGHTERS GRANT PROGRAM

SUMMARY BACKGROUND:

The city of Greenville Fire Department applied for and was awarded a grant in the amount of \$27,454.55 from the U.S. Department of Homeland Security, Federal Emergency Management Agency FY 2020 Assistance to Firefighters Grant (AFG) Program. The award will be used to purchase necessary equipment for the Department. Equipment needs include cordless cut-off saws, 5-gas meters and vehicle extrication tools. The grant requires a 10% percent match of \$2,745.45, for a total project budget of \$30,200.

IMPACT IF DENIED:

The grant will not be accepted and the equipment will not be purchased.

FINANCIAL IMPACT:

The AFG program requires a 10% percent local match. For this project, the required match amounts to \$2,745.45. The Fire Department General Fund has sufficient funds for the match.

WHEREAS, the city of Greenville Fire Department (the “GFD”) applied for and was awarded a grant in the amount of \$27,454.55 from the U.S. Department of Homeland Security, Federal Emergency Management Agency FY 2020 Assistance to Fire Firefighters Grant (AFG) Program; and

WHEREAS, the funds received will be used to purchase cordless cut-off saws, 5-gas meters, and vehicle extrication tools; and

WHEREAS, the GFD will use funds from the Fire Department General Fund to contribute a required ten percent local match for the AFG grant award in the amount of \$2,745.45;

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF GREENVILLE, SOUTH CAROLINA, the amount of \$30,200 is appropriated in the Miscellaneous Grant Fund to support the GFD’s equipment needs as reflected in the attached Exhibit. This Ordinance shall become effective upon passage on the second and final reading.
