ORDINANCE TO APPROPRIATE \$2,407,197 IN FUNDING IN THE CAPITAL PROJECTS, HOSPITALITY TAX AND LOCAL ACCOMMODATIONS TAX FUNDS FOR CONSTRUCTION OF SWAMP RABBIT TRAIL PEDESTRIAN BRIDGES

SUMMARY BACKGROUND:

Greenville County staff issued an RFP (#21084) in May 2021 for the construction of bridges on the Laurens Road Swamp Rabbit Trail extension. City staff participated in the evaluation of the RFP and have continued negotiations with the top scored firm.

The City will be taking over the management of the construction of the bridges from the County, per Resolution No. 2021-31 authorized by City Council on September 27, 2021. This action is to appropriate the additional funding necessary to complete the Laurens Road and Haywood Road bridges. The Woodruff Road bridge will be handled by Greenville County.

IMPACT IF DENIED:

The City will not be able to complete the pedestrian bridge construction.

FINANCIAL IMPACT:

This action will reduce the available fund balance in the Hospitality Tax and Local Accommodations Funds. Sufficient funding is available for the appropriation.

AN ORDINANCE

TO APPROPRIATE \$2,407,197 IN FUNDING IN THE CAPITAL PROJECTS, HOSPITALITY TAX AND LOCAL ACCOMMODATIONS TAX FUNDS FOR CONSTRUCTION OF SWAMP RABBIT TRAIL PEDESTRIAN BRIDGES

WHEREAS, Greenville County issued RFP #21084 on May 17, 2021, seeking construction services related to pedestrian bridges along the Prisma Health Swamp Rabbit Trail; and

WHEREAS, City Staff participated in the evaluation of proposals in conjunction with Greenville County Procurement and have continued evaluations and negotiations with the top scored firms; and

WHEREAS, the city of Greenville will fund and manage the construction of the pedestrian bridges at Laurens Road and Haywood Road; and

WHEREAS, the City recognizes the importance of the Bridges to the overall safety and usability of this Swamp Rabbit Trail extension; and

WHEREAS, City Council adopted Resolution No. 2021-31 on September 27, 2021, authorizing the City Manager to award a contract for the project construction;

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF GREENVILLE, SOUTH CAROLINA, to appropriate \$2,407,197 in the Capital Projects, Hospitality Tax and Local Accommodations Tax Funds as reflected in the attached Exhibit for construction of the Swamp Rabbit Trail Pedestrian Bridges.
