AN ORDINANCE TO APPROPRIATE \$233,918 IN THE CAPITAL PROJECTS FUND TO RECOGNIZE SCDOT REVENUES FOR THE HAYWOOD ROAD SIDEWALK PROJECT

SUMMARY BACKGROUND:

The city of Greenville (the "City") was approved \$233,918 in funding from SCDOT for the Haywood Road Sidewalks Project. The project consisted of the construction of approximately 1500 linear feet of new sidewalk along the east side of Haywood Road from the Haywood Mall entrance to 700 feet past Woods Crossing Road, and was completed in May 2022. The total cost of the project was at \$292,397 of which the City is responsible for a 20% percent match.

The project was administered through a participation agreement with SCDOT whereby the City performed the project and will now receive funding reimbursement as the project is completed. The City's local match of \$100,000 was previously appropriated in the FY 2015-16 Capital Improvement Program. This Ordinance will appropriate the approved SCDOT funds necessary to close out the project.

IMPACT IF DENIED:

If denied, the City will not receive the SCDOT portion of funding for this project.

FINANCIAL IMPACT:

N/A. The project is complete and local matching funds have already been appropriated.

AN ORDINANCE

TO APPROPRIATE \$233,918 IN THE CAPITAL PROJECTS FUND TO RECOGNIZE SCDOT REVENUES FOR THE HAYWOOD ROAD SIDEWALK PROJECT

WHEREAS, the city of Greenville (the “City”) was approved \$233,918 in Transportation Alternative Program (“TAP”) funds from the South Carolina Department of Transportation (“SCDOT”) for the Haywood Road Sidewalks Project.; and

WHEREAS, the City was approved by SCDOT as a Local Public Agency to manage the project and entered into a participation agreement with SCDOT to administer the project; and

WHEREAS, the City will be responsible for a 20% percent local match for the project and has previously appropriated \$100,000 in General Funds to the project to meet the local match requirement; and

WHEREAS, no additional City funds will be needed to complete the project, and construction has been completed;

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF GREENVILLE, SOUTH CAROLINA, the amount of \$233,918 is appropriated in the Capital Projects Fund as reflected in the attached Exhibit for the purpose of project implementation in accordance with an executed participation agreement between the City of Greenville and South Carolina Department of Transportation. This ordinance shall become effective upon passage on the second and final reading.
