ORDINANCE TO AMEND SECTION 2-427, MEMBERSHIP, YOUTH COMMISSION OF THE CODE OF ORDINANCES OF THE CITY OF GREENVILLE

**SUMMARY BACKGROUND:**

City Council previously approved Resolution No. 2016-63 amending certain sections of the Bylaws of the Youth Commission. The City Clerk's Office recently found that Section 2-427, Membership, of the Code of Ordinances of the City of Greenville should have been updated by Ordinance at the time the Resolution was approved, as required under South Carolina Code §5-7-260.

This Ordinance allows for the Code of Ordinances to be updated to include the amended language previously approved by City Council.

## A N O R D I N A N C E

## TO AMEND SECTION 2-427 YOUTH COMMISSION, MEMBERSHIP, OF THE CODE OF ORDINANCES OF THE CITY OF GREENVILLE

WHEREAS, City Council previously approved Resolution No. 2016-63 amending certain sections of the Bylaws of the Youth Commission; and

WHEREAS, it was recently determined that Section 2-427, Membership, of the Code of Ordinances of the City of Greenville should have been updated by Ordinance at the time the Resolution was approved, as required under South Carolina Code §5-7-260; and

WHEREAS, the following language is provided for Council's approval by Ordinance and is shown as additions and strikeouts as originally presented:

Sec. 2-427. - Membership.

The commission shall consist of the following:

- (1) A minimum of 10 ~~16~~ and a maximum of 24 members.
- (2) Members shall be young people who reside in the city of Greenville, or up to 20 percent of the entire committee that attend high school in the city of Greenville that are ~~shall~~ reside in the city and be enrolled in or entering grades 9 through 12. Also, membership shall include not more than two members up to age 21 who are ~~and can include no more than four members~~ enrolled in a city four-year college or university or two-year community college.
- (3) Members shall be recruited and nominated by staff and youth commissioners through an application process and approved by the city council.
- (4) Members serve without compensation.
- (5) Members' term of office shall be yearly with eligibility to continue until they reach the commission's school grade limit, provided members are nominated on an annual basis.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF GREENVILLE, SOUTH CAROLINA, Section 2-427, Membership, of the Code of Ordinances of the City of Greenville is amended as provided above. The Ordinance shall become effective upon second and final reading.
