AN ORDINANCE TO APPROPRIATE \$45,000 IN THE MISCELLANEOUS GRANT FUND FOR THE FY 2022 SOUTH CAROLINA STATE HOMELAND SECURITY GRANT PROGRAM.

SUMMARY BACKGROUND:

The City of Greenville Fire Department received a grant in the amount of \$45,000 from the South Carolina Law Enforcement Division through the 2022 South Carolina State Homeland Security Program. The grant will be used for sustainment and training for the Upstate Regional Collapse Search & Rescue Team. No additional funds will be needed to complete the project.
