RESOLUTION TO ACCEPT \$25,000 IN DONATED FUNDS FROM COLDWELL BANKER CAINE VIA LEGACY PARK FRIENDS FOR THE ADDITION OF AMENITIES AT LEGACY PARK

SUMMARY BACKGROUND:

Legacy Park Friends (LPF) is a nonprofit organization that works in partnership with the city of Greenville (the "City") to preserve and enhance Legacy Park. LPF exists to support the City's Parks, Recreation & Tourism Department through volunteerism and fund-raising with the goal of maintaining and improving the appeal, appearance, and functionality of Legacy Park.

Coldwell Banker Caine has made a \$25,000 donation to Legacy Park Friends to be used for the procurement and installation of a sensory station adjacent to the playground area. LPF has sent the \$25,000 donation to the City for this designated purpose.

IMPACT IF DENIED:

Sensory Station will not be added adjacent to the playground area, and the donation will be returned to the donor, Coldwell Banker Caine.

There is no financial impact on the City for this item.

A RESOLUTION
