ORDINANCE TO APPROPRIATE \$1,000,000 IN THE MISCELLANEOUS GRANT FUND FOR SCTF-6 A REGIONAL URBAN/COLLAPSE SEARCH & RESCUE TEAM HOSTED BY GREENVILLE CITY FIRE DEPARTMENT

SUMMARY BACKGROUND:

The South Carolina Department of Labor, Licensing and Regulation, Division of Fire and Life Safety (SCDLLR/DFLS) has entered into an agreement with the Greenville City Fire Department, on behalf of the city of Greenville, to provide non-recurring funds from the South Carolina State budget to support SCTF-6, a Regional Urban/Collapse Search & Rescue Team hosted by the Greenville City Fire Department. SCFT-6 is recognized by the State of South Carolina Homeland Security Plan and the South Carolina Firefighter Mobilization Plan. The funds will used to purchase new and replacement equipment and supplies and to provide training for SCFT-6.

IMPACT IF DENIED:

The City will have to reject the funds.

None. No additional funds are needed from the City of Greenville to complete this project.

WHEREAS, no additional funds from the city of Greenville are needed to complete this project;

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF GREENVILLE, SOUTH CAROLINA, the amount of \$1,000,000 is appropriated in the Miscellaneous Grant Fund for SCTF-6 as reflected in the attached Exhibit. This Ordinance shall become effective upon passage on the second and final reading.
