The Greenville Police Department will use these funds to continue special operations focused on alcohol enforcement within the jurisdiction of the Department.


**IMPACT IF DENIED:**





TO APPROPRIATE \$1,500 IN THE MISCELLANEOUS GRANTS FUND FROM THE PHOENIX CENTER TO FUND THE GREENVILLE POLICE DEPARTMENT'S ALCOHOL ENFORCEMENT TEAM'S ENFORCEMENT ACTIVITIES

WHEREAS, the Greenville Police Department has an ongoing partnership with the Thirteenth Circuit Alcohol Enforcement Team; and

WHEREAS, the Department has received \$1,500 in funds from the Phoenix Center to support underage drinking enforcement; and

WHEREAS, the Department wishes to use these funds in their Alcohol Enforcement Team initiatives;

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF GREENVILLE, SOUTH CAROLINA, the amount of \$1,500 received from the Phoenix Center shall be used by the Greenville Police Department to further the efforts of the Alcohol Enforcement Team as reflected in the attached Exhibit. This Ordinance shall become effective on the second and final reading.
