TO APPROPRIATE \$26,080 IN THE LAW ENFORCEMENT SPECIAL REVENUE FUND, DEPARTMENT OF HOMELAND SECURITY ACCOUNT, AND TO ACCEPT A GRANT AWARD IN THE AMOUNT OF \$26,080 FROM THE OFFICE OF JUSTICE PROGRAMS, BULLETPROOF VEST PARTNERSHIP FOR THE PURPOSE OF FUNDING THE PURCHASE OF BODY ARMOR FOR THE GREENVILLE POLICE DEPARTMENT

**SUMMARY BACKGROUND:**

The Greenville Police Department has received a grant of \$26,080 from the Department of Homeland Security. The Department will use these funds along with a \$26,080 match from the Law Enforcement Special Revenue Fund, to purchase body armor for the staff. Ballistic vests have a 5 year expiration, and the department has an ongoing program to ensure they are replaced in accordance with National Institute of Justice standards and manufacturer recommendations.




If denied, the City will need to identify another funding source for the purchase of these items.




The appropriation would enhance the safety of our officers with no impact on our baseline budget.

WHEREAS, the Greenville Police Department has an ongoing need to ensure its personnel are outfitted with ballistic vests; and

WHEREAS, the Department has received \$26,080 in grant funds from the Office of Justice Programs, Bulletproof Vest Partnership Program; and

WHEREAS, \$26,080 is available in the Law Enforcement Special Revenue Fund, Department of Homeland Security Account as matching funds;

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF GREENVILLE, SOUTH CAROLINA, the sum of \$52,160 is appropriated for the purpose of purchasing ballistic vests for the Greenville Police Department as reflected in the attached Exhibit. This Ordinance shall become effective on the second and final reading.
