ORDINANCE/RESOLUTION CAPTION:

AN ORDINANCE TO APPROPRIATE \$486,217 IN THE GENERAL FUND FOR THE RESTORATION OF THE BOBBY PEARSE COMMUNITY CENTER

SUMMARY BACKGROUND:

A tree fell onto the Bobby Pearse Community Center in May of 2018 resulting in structural damage. The City's Purchasing Department issued an Invitation for Bids in October 2020 to address the structural and civil components of the site. The lowest responsive bid was \$359,982. Additional costs related to furniture, fixtures, equipment and design total \$126,235. This appropriation includes construction of a new ADA compliant parking lot, repairs to the existing building, additional roofing and painting needs, furniture, fixtures, and equipment needed for the facility to function when the project is complete.

The General Fund has sufficient fund balance for this renovation. Any insurance proceeds received will be used to offset the General Fund's contribution to this project.

IMPACT IF DENIED:

The Bobby Pearse Community Center will not be restored.

FINANCIAL IMPACT:

This Ordinance will appropriate \$486,217 from General Fund fund balance. Sufficient fund balance above the 20% percent required reserve is available for this appropriation.

TO APPROPRIATE \$486,217 IN THE GENERAL FUND FOR THE RESTORATION OF THE BOBBY PEARSE COMMUNITY CENTER

WHEREAS, a tree damaged the roof and surrounding structure of the Bobby Pearse Community Center (the "Center") in May of 2018; and

WHEREAS, the Purchasing Department has obtained bids from three qualified contractors for repairs at the Center; and

WHEREAS, the lowest responsive bid is \$359,982; and

WHEREAS, additional furniture, fixtures, equipment and design total \$126,235; and

WHEREAS, sufficient fund balance is available in the General Fund for these repairs; and

WHEREAS, any insurance proceeds related to these repairs shall offset the General Fund's contribution to this project;

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF GREENVILLE, SOUTH CAROLINA, the amount of \$486,217 is appropriated in the General Fund for the purpose of restoring the Center as reflected in the attached Exhibit. This Ordinance shall become effective upon passage on the second and final reading.
