ORDINANCE TO APPROPRIATE \$84,400 IN THE MISCELLANEOUS GRANT FUND FOR THE PROVIDING OPPORTUNITIES FOR LIFELONG LEARNING GRANT

SUMMARY BACKGROUND:

The city of Greenville's Parks, Recreation and Tourism Department received a Providing Opportunities for Lifelong Learning Grant totaling \$84,400 from the S.C. Afterschool Alliance. The funding for the grant is made available through South Carolina Department of Education American Rescue Plan funds and the Governor's Emergency Education Relief Fund. The funds will be used to support afterschool and summer programs at the City's community centers.

AN ORDINANCE

TO APPROPRIATE \$84,400 IN THE MISCELLANEOUS GRANT FUND FOR PROVIDING OPPORTUNITIES FOR LIFELONG LEARNING GRANT

WHEREAS, the city of Greenville’s Parks, Recreation and Tourism Department received a Providing Opportunities for Lifelong Learning Grant totaling \$84,400 from the SC Afterschool Alliance through South Carolina Department of Education American Rescue Plan funds and the Governor’s Emergency Education Relief Fund; and

WHEREAS, the funds received will be used to support afterschool and summer programs at the city’s community centers; and

WHEREAS, no additional funds are needed to complete this project;

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF GREENVILLE, SOUTH CAROLINA, the amount of \$84,400 is appropriated in the Miscellaneous Grant Fund for the Providing Opportunities for Lifelong Learning Grant to support the Parks, Recreation and Tourism Department’s afterschool and summer program activities as reflected in the attached Exhibit. This Ordinance shall become effective upon passage on the second and final reading.
