ORDINANCE TO APPROPRIATE \$35,000 IN DONATED FUNDS FROM STEVE WHITE AUTO GROUP THROUGH LEGACY PARK FRIENDS FOR THE ADDITION OF AMENITIES AT LEGACY PARK

SUMMARY BACKGROUND:

Legacy Park Friends (LPF) is a nonprofit organization that works in partnership with the city of Greenville, South Carolina to preserve and enhance Legacy Park. LPF exists to support the city of Greenville's Parks, Recreation and Tourism Department through volunteerism and fund-raising with the goal of maintaining and improving the appeal, appearance, and functionality of Legacy Park.

Steve White Auto Group has made a \$35,000 donation to LPF to be used for the procurement and installation of two (2) sunshades and two (2) picnic tables in the playground area. LPF has sent the \$35,000 donation to the city of Greenville for this designated purpose.

IMPACT IF DENIED:

Sunshades and picnic tables will not be added to the playground area, and the donation will be returned to the donor, Steve White Auto Group.

There is no financial impact on the City for this item.

AN ORDINANCE

TO APPROPRIATE \$35,000 IN DONATED FUNDS FROM STEVE WHITE AUTO GROUP THROUGH LEGACY PARK FRIENDS FOR THE ADDITION OF AMENITIES AT LEGACY PARK

WHEREAS, the city of Greenville has received a donation in the amount of \$35,000 from Steve White Auto Group through Legacy Park Friends to procure and install two sunshades and two picnic tables for Legacy Park; and

WHEREAS, \$32,217.15 of the donation will be used to procure and install two sunshades in the playground area; and

WHEREAS, \$2,782.85 of the donation will be used to procure two picnic tables to be placed under the sunshades;

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF GREENVILLE, SOUTH CAROLINA, the amount of \$35,000 is appropriated in the Donations Fund for a donation from Steve White Auto Group through Legacy Park Friends as reflected in the attached Exhibit A. This Ordinance shall become effective upon passage on the second and final reading.
